



TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE NO. 24 - 04

An ordinance levying taxes for all town purposes for **JARVIS TOWNSHIP, Madison County, Illinois**, for the tax year **2024**, collectable in **2025**.

BE IT ORDAINED by the Board of Trustees of **JARVIS TOWNSHIP, Madison County, Illinois**, as follows:

SECTION 1: That the sum of **FOUR HUNDRED FORTY THOUSAND FIVE HUNDRED Dollars (\$440,500.00)** are hereby levied upon all property subject to taxation within **JARVIS TOWNSHIP** as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of **JARVIS TOWNSHIP**, as required by statute or voted by the people in accordance with the law, for such purposes as:
