



TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE NO. 25 - 02

An ordinance levying taxes for all town purposes for **JARVIS TOWNSHIP, Madison County, Illinois**, for the tax year **2025**, collectable in **2026**.

BE IT ORDAINED by the Board of Trustees of **JARVIS TOWNSHIP, Madison County, Illinois**, as follows:

SECTION 1: That the sum of **FOUR HUNDRED SIXTY-TWO THOUSAND FIVE HUNDRED Dollars (\$462,500.00)** are hereby levied upon all property subject to taxation within **JARVIS TOWNSHIP** as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of **JARVIS TOWNSHIP**, as required by statute or voted by the people in accordance with the law, for such purposes as:

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.
